Mr. Bergman Promotes Asia's Growing Role in International Dental Community, Praises Global Impact of ICD Member Volunteerism

Of the many wonderful leadership lessons to be learned from Nelson Mandela's life, I believe that this is the most important – 'It always seems impossible until it's done.' As you return to your respective countries and your individual practices and encounter new challenges, please remember that nothing is impossible."

Presented in collaboration with the Macau Dental Association, the ICD Congress featured an educational program presented by a world-class line-up of international dental experts and a trade show focused on the latest advances in dental technology.
