

Henry Schein Acquires Dental Distributors in Australia and New Zealand

MELVILLE, N.Y.--(BUSINESS WIRE)--May 16, 2005--Henry Schein, Inc. (Nasdaq NM: HSIC), the largest provider of healthcare products and services to office-based practitioners in the combined North American and European markets, today announced the acquisition of Halas Dental Ltd. and Shalfoon Bros. Ltd., full-service providers of dental merchandise and equipment in Australia and New Zealand, respectively. Henry Schein purchased these businesses from Australian Pharmaceutical Industries Limited (API) (ASX: API) Henry Schein did not disclose terms of the transaction.

Halas Dental and Shalfoon are expected to contribute combined revenues of approximately AUD 80 million in the first 12 months of operations after the acquisition. Henry Schein expects this acquisition to be slightly accretive in 2005. Anticipating that it may realize future operational efficiencies from the acquisition, the Company expects a greater contribution to earnings in 2006 and beyond.

"Halas and Shalfoon have enjoyed a long and successful heritage in Australia and New Zealand, respectively, resulting in a strong brand identity, numerous product exclusives and an excellent customer base," said Stanley M. Bergman, Chairman and Chief Executive Officer of Henry Schein. "With this acquisition and Henry Schein's existing Australian and New Zealand operations, we are firmly positioned as a leading dental distributor in these two countries, offering a wide selection of products and services designed to help practitioners operate more efficient and profitable practices while delivering high-quality dental care."

Mr. Bergman added, "In addition, the increase in our critical mass will offer us the opportunity to provide our valued vendor partners with enhanced supply chain efficiencies and increased potential for growth in product market share."

Henry Schein is pleased to welcome the Halas and Shalfoon teams under the leadership of Andrew Hoggard, Halas General Manager, and Gail Stewart, Shalfoon Brothers General Manager. Gordon Anderson, General Manager for Henry Schein's current Australian and New Zealand operations, will oversee the Halas and Shalfoon businesses, as well.

"We are extremely pleased to become part of the Henry Schein family of companies," said Mr. Hoggard. "Everyone involved recognizes the great benefit of combining the regional expertise of Halas and Shalfoon with the global resources and reputation of Henry Schein, an international leader in dental and other healthcare products and services, including premier technology products. These companies share a common commitment to our customers, and we look forward to enhancing our offering as we work in tandem with each other."

The acquisition of Halas and Shalfoon adds more than 50 sales representatives to Henry Schein's existing Australian and New Zealand sales force of nearly 60.
