The 2011 Shils-Meskin Award winner was Dr. Harold Slavkin, Professor of Dentistry at the Herman Ostrow School of Dentistry, University of Southern California, and former Dean of the dental school and Director of the National Institute of Dental and Craniofacial Research (NIDCR) within the National Institutes of Health. Special Recognition Awards were given to Jeffrey Perelman, Chairman and CEO of JEP Management, Inc.; and Senior Mobile Dental. The Founder Award was given to Stephen Boss – the first ever student to receive the award – who is in the top-ten ranking of his class at Columbia University College of Dental Medicine, an ASDA Board Trustee and Delegate, and a researcher on diabetes, maxillofacial projects and osteogenesis work.
