**Explanation of Responses:**

- On April 1, 2014, Mr. Kabat transferred 2,481 shares held directly to a trust where Mr. Kabat and his wife are co-trustees of the trust for the benefit of Mr. Kabat's wife (the "Trust").

- Acquired pursuant to the Issuer's 1996 Non-Employee Director Stock Incentive Plan, as amended.
- The option vested in four equal installments on each of March 9, 2006, March 9, 2007, March 9, 2008 and March 9, 2009.
